We agree as the promoting body that if recognition as an affiliated show is granted, we will ensure: -

- α) Affiliation fee includes free insertion into The UK Ponies & Horses Show Directory and regular updates on UK Ponies & Horses website and Facebook page. Affiliation will not be accepted until the the Affiliation form and fee has been received, after which an Affiliation Number will be issued.
- β) That the rules of UK Ponies & Horses as published in the Associations Current Rule Book will be observed and applied in full.
- γ) That the draft schedule which must include **the Judges names** will be forwarded to the UK Ponies & Horses office at least **4 weeks** before the scheduled event for approval, and the allocation of an affiliation number, which must be printed on the front cover of the final schedule. All amendments requested must be incorporated and approved before the final schedule is printed.
- δ) That qualifying classes are scheduled by your Committee for 2025 before applying to UK Ponies & Horses.
- ε) **That the pre entries for all four classes are to be sent to the UK Ponies & Horses Admin Office at least 4 days prior to the event, to allow for memberships and registrations to be checked.**
- φ) Results of the classes must be sent to the Admin Office within **48 hours** of the show to allow for the UK Ponies & Horses Wild Card Series to be updated.
- γ) The highest placed exhibit not already qualified within the first five will qualify for the UK Ponies & Horses RIHS Young Riders & Amateur class.
- η) That Judges and wording used in the schedule to describe qualifying classes are correct according to the UK Ponies & Horses current Rule Book.
- ι) That the promoting body will comply with all appropriate regulations relating to health and safety requirements, provisions of medical services and supplies, and fire precautions and that it will be the sole responsibility of the promoting body to ascertain from the appropriate authorities, the extent and nature of these obligations. That the promoting body will comply with the general duties under the Health and Safety at Work Act 1974, and ensure the health and safety of all persons, whether they are organisers, officials, participants or members of the public or any other person who may be affected whilst at the event.
- φ) Individual members and organisers of affiliated shows MUST HAVE Public Liability Insurance for an adequate limit of indemnity and valid for the day/s of the show/s. UK Ponies & Horses has their own cover to protect their liability, but this does not extend to cover the negligence of individual members or organisers of Affiliated Shows

**Please note that if you are on an organising committee of a show holding RIHS qualifiers, you cannot compete in the RIHS qualifiers: this would also include immediate family members.**
